

MyHR - Interviews on use and experience

Are you a GP, pharmacist, allied health professional or private specialist who uses the My Health Record (MyHR) in your practice? Share your experiences and help shape the MyHR Expansion Program.

The Australian Digital Health Agency would like to hear from healthcare providers about how the use of the MyHR has affected the delivery of patient care by your organisation.

This would be done through up to three face-to-face interviews with professionals working in general practice, pharmacy, allied health and private specialist fields.

The interviews will help inform the direction of the MyHR Expansion Program, with the Australian Government committed to creating a MyHR for every Australian by the end of 2018, unless they opt out.

The MyHR system provides timely access to clinically-relevant information from healthcare providers and consumers that can be used to ensure the provision of the most appropriate treatment for patients. This can include information contained in hospital discharge summaries, shared health summaries from general practitioners, and information about over-the-counter medications.

Eligibility Criteria

To be eligible for the interviews applicants must:

- Be a general practitioner, community pharmacist, allied health provider or private specialist
- Be located within and provide services to the NWMPHN region;
- Be registered and participating in the My Health Record; and,
- Be available to complete the three 60-minute interviews spaced five months apart over the course of the My HR Expansion Program, OR
- Be available to complete one 60-minute interview at a point in time over the course of the My HR Expansion Program (to 30 June 2019)

Approximate timelines and activities

The series of three interviews will take place between:

- Dec 2017 Feb 2018
- May July 2018
- Oct Dec 2018

Time commitment

Each interview is expected to take approximately one hour and will be conducted at a location convenient to the interviewee. Financial support will be provided based on the NWMPHN Stakeholder Reimbursement Policy.
