| <p>Option 3: Submit PIP Eligible Data Set manually to the PHN Portal</p> | <p>General practices extract a (JSON file) from their clinical information system of aggregated PIP Eligible Data set.</p> <p>JSON file is then uploaded to the PHN portal.</p> | <p>Nil</p> | <p>Practice is responsible for ensuring that the JSON file is extracted from their clinical system in the correct format.</p> <p>Practice is responsible for ensuring that data is received quarterly in the PHN portal.</p> | <p>Ensuring the JSON file is generated from clinical information system in the required format.</p> | <p>Practices are responsible for any costs incurred for generating a JSON file.</p> <p>There is no cost to practices to use the PHN portal.</p> | <p>Overview of de-identified data submission process via portal here.</p> |
