| Do all members of<br>practice team (GP,<br>practice nurse and<br>practice manager) have<br>to attend the learning<br>workshops together or<br>can one or two of them<br>attend and share notes<br>with another? | A minimum of 3 participants including at least one GP need to attend<br>each workshop. In exceptional circumstances where a project participant<br>cannot attend on the evening, we may then look to share workshop<br>recording, or then have other team members share notes. |
| Can you provide the<br>tentative dates of<br>learning workshops so  | The dates are to be confirmed and will most probably be in the last 2 weeks of April, July and October 2023.   |

| Does practice need to<br>commit to a GP<br>attending the 3<br>workshops?  | We do require practices to commit to one GP attending all 3 workshops<br>which will be 1.5 hours each and in a virtual format held in the evening<br>(workshop 1 – April 2023, workshop 2 - July 2023 and Workshop 3 - Oct<br>2023 with dates to be confirmed). It doesn't need to be the same GP<br>attending all 3 workshops as it is intended that practice teams will share<br>their insights across their practice teams following the workshops. |
| What if a practice is<br>limited to only 2<br>members i.e. a solo GP<br>working with a practice<br>manager or practice<br>nurse only. | If a practice has only 2 members (one being a GP, and the other role<br>being a practice manager and/ or a practice nurse) the EOI application<br>will be considered.  |
